Implications for Department Budget and Resources

Action Steps that Have Improved Student Learning

Although we have not had budget funds allocated as noted above, I did utilize some budget funds to provide refreshments at a "retreat" with our Spanish instructors this past summer, in order to help them be recognized for their additional service to the institution through assessment reporting.

One of our challenges from our last report for Spanish for Service and the Professions was to address the issue of students coming into our intermediate course with a wide range of Spanish competency. Instructors are now providing supplemental instruction materials to help students "catch up" to intermediate college level where needed. Time will continue to tell if this has helped improved learning. Our 2022-23 assessment may reveal if there has been improvement.
