### Statewide Survey of Ohio Resident Educators' Reflections on their Educator Preparation Program

Reporting period from September 1, 2020 to August 31, 2023.

#### Description of Data:

To gather information on alumni satisfaction with the quality of preparation provided by their educator preparation programs, the Ohio Department of Higher Education administers a survey aligned with the Ohio Standards for the Teaching Profession (OSTP), Ohio licensure requirements, and elements of national accreditation. All Ohio Resident Educators who completed their preparation in Ohio receive an invitation to complete the survey in the fall semester as they enter Year 2 of the Resident Educator program. A total of 615 respondents completed the survey statewide for a response rate of 14.2 percent.
