



- Step 1** Review the online course schedule and degree audit, selecting the courses required in your program and those of interest. You should have your courses selected prior to Step 2.
- Step 2** Make an appointment to communicate electronically with your Academic Advisor to have your course selections reviewed. **Academic Advising will take place from March 14th-20th.** If you are using Web Registration, make sure your academic advisor has cleared you for registration. If you are planning to drop off your Course Registration Form, be sure to have your Academic Advisor sign this form.
- Step 3** Log in to MaloneXpress to register for your selected courses according to the scheduled times below. If you are not using Web Registration to select your schedule, you must return the advisor-signed Course Registration Form to the Office of the Registrar according to the scheduled times below.

- Step 4** Review your course schedule through MaloneXpress. Your online schedule will reflect those courses for which you were permitted to enroll. Closed classes or courses in which you did not meet the required prerequisite(s) will be missing from your online schedule. Those using Web Registration will immediately know the status of their scheduled courses. Students can make corrections or select other courses through Web Registration until **Sunday, August 25, 2024**, or stop in the Office of the Registrar to complete your registration.
- Step 5** Official fall bills will be issued in July. You should be prepared to make your first payment to the Business Office by **August 3, 2024**.
