## **Mission Statement:**

The primary purpose of the Department of Visual Arts at Malone University is to provide students with an opportunity to acquire the skills and knowledge necessary to become competent artists. This process takes place in a Christian environment where serious art studies find common ground with the liberal arts and the practical demands of the profession. By providing a solid art curriculum, it is the intention of the Department of Visual Arts to prepare the student for those life-long experiences they may encounter in art and as artists and individuals who seek creative expression.

## **Program Goals:**

- To provide a well-qualified faculty that takes a special interest in the holistic development of students;
- To present a curriculum that emphasizes the elements and principles of art and an historical context for visual arts;
- To provide instruction in the discipline of art which will prepare students to be teachers, artists, and to appreciate the arts;
- To create an exciting and challenging environment where inquiry and experimentation give way to understanding, knowledge and appreciation for a variety of artistic styles and methods;
- To provide opportunities for students to participate in a wide variety of experiences that are characterized by the skill and aesthetic expression such as museum visits, gallery tours, and guest lectures and demonstrations;
- To provide exhibits which enhance the cultural life of the Malone community, the greater Canton community and the broader Malone constituency;
- To broaden the aesthetic awareness of the general student population through general education courses in the arts;
- To impress upon students their responsibility for stewardship in the arts;
- To provide opportunities for students to express their Christian faith through art;
- To provide preparation for graduate study.

B. 100% of the students are expected to write a one-page critical analysis stating their individual beliefs in how Christian faith relates to Visual Arts during their freshman portfolio review (ART 105), and ART 460 – Issues in Contemporary Art with a B or higher. During Junior Review, students will write a critical analysis of an abstract artwork.	There was no data available for Freshman Portfolio Review. The average score in ART 460 was 85%. The critical analysis paper completed at the Junior Review was completed by 9 of 9 students with an average score of 81.1%.	In addition to the grade requirements, the faculty will continue to monitor improvement in student writing skills from freshman to senior year. Due to the many curriculum changes in the Visual Arts department, one of them being the cancellation of Art Fundamentals and the Freshman Portfolio Review, the critical analysis papers will be assigned during ART 105 (freshman), the junior review, and ART 460 (senior). Since ART 105 was not offered during spring 2016, no results are available for this assessment report.

## **Notes:**

The Department of Visual Art underwent significant change during the 2012-13 academic year with regards to faculty retirements. In order to increase enrollment in the art department courses and to develop a more engaging General Education Fine Arts Menu, several courses in the art program became general education offerings: Drawing I, Fibers I and II, Photography I, Ceramics I, 2D Design, and 3D Design. To reduce the effect the inclusion of students from the general student population would have on the assessment report, the data included in the report is limited to the visual art majors. The department has reviewed and is adapting the assessment tools to reflect the new art curriculum adopted in 2014-15. Some data to be assessed will be inconclusive until students have advanced through the new majors added that year.

The Visual Arts department pre-test will be given during the ART 105: Freshman Seminar course offered each spring semester and serve as the baseline for assessment. The three area pre-tests for the Bachelor of Arts with emphasis in Art History, Fine Arts and Crafts, and Graphic Design and Digital Arts will be given during ART 105 regardless of the students declared area of visual arts emphasis when entering Malone University. Post-tests will be administered during ART 430: Senior Exhibit. The critical analysis papers will be administered during ART 105, the Junior Review, and during ART 460: Issues in Contemporary Art.
